#### Implementation of GOCO (Government Owned Corporate Operated) Model at 505 Army Base Workshop

#### **Introduction**

- 1. Indian Army invites Request for Information (RFI) from the interested bidders for undertaking the operations of 505 Army Base Workshop (ABW) under the Government Owned Corporate Operated model by Indian private sector.
- 2. The purpose of this Request for Information (RFI) is to identify prospective bidders to undertake operations of 505 ABW under GOCO model.
- 3. Only private entities are eligible to respond to this RFI. DPSUs and OFBs are not eligible to participate in this project.
- 4. The broad scope of work is briefly described in the following sections.

#### Overview of Project GOCO

- 5. Army Base Workshops are an important part of the industrial base of Indian Defence forces. Eight Army Base Workshops (ABWs) were established during the Second World War to carry out repairs and overhaul of weapons, vehicles and equipment to keep the Indian Army operationally ready. These ABWs play important role in reset and regeneration of combat capability of Army.
- 6. Army Base Workshops (ABWs) carry out base repairs and overhaul of weapons, vehicles and equipment to keep the Indian Army operationally ready both during peace and war. They also undertake manufacture and indigenization of spares. In a bid to enhance the combat potential of the Armed Forces, a Committee of Experts (CoE) under the Chairmanship of Lt Gen DB Shekatkar (Retd), was constituted in 2016 to identify and recommend methods to meet the objective of an agile but effective military to meet current and future threats that the country faces.
- 7. Based on the recommendations of this Committee, a decision has been taken by the Ministry of Defence (MoD) to outsource the functioning of the ABWs to private sector players towards operating the workshop in the Government Owned Corporate Operated model. 505 ABW, Delhi Cantt is to be the first ABW to be put on the GOCO Model.

#### Overview of the 505 ABW

8. 505 Army Base Workshop has historically overhauled and carried out Base repairs of tanks as well as engines and major/minor assemblies of tanks. It currently overhauls 70 x T-72 tanks annually and its associated engine, assemblies etc. 505 ABW is scheduled to start all these activities for tank T-90 from FY 2020-21. Spares required for the overhaul activity are currently sourced from Ordnance Factories, DPSUs, ex Trade and from OEMs (ex Import).

#### **Broad Scope of Work**

9. The bidder will be required to carry out the overhaul of Tank T-72 and T-90, repair of tank T-72 and T-90 Class B rotables including engine and Base repair of major and minor assemblies of tank T-72 and T-90. The bidder would be required to perform these activities with optimum processes and best practices for tank overhaul/ repair.

#### **Requested Information**

10. The bidder should provide information and supporting documents as enumerated in the succeeding paragraphs.

#### (a) Organisation Information

- (i) Copy of certificate of incorporation or certified copy of partnership deed to showcase that bidder is a registered firm under the Indian Companies Act 2015 or a Partnership firm registered under Indian Partnership Act, 1932. The bidder organization should be operational in India for at least 5 years as on 31 March 2020.
- (ii) Undertaking from authorized signatory certifying that the bidder has not been declared ineligible due to unsatisfactory past performance, corrupt, fraudulent or any other unethical business practices by Indian Army / MoD/ any State Government/ Central Government/ PSUs.
- (iii) Undertaking from authorized signatory certifying that the bidder has not been banned/blacklisted by any State / Central Government/ Public Sector Undertakings (PSUs).
- (iv) Organization details of the bidder to be furnished as per the format provided in the **Appendix B.**

#### (b) Financial Information

Financial information of the bidder related to financial capacity such as annual turnover, net worth and profitability are to be furnished in the format provided in the **Appendix C** 

#### (c) Similar project experience

Bidder's relevant experience to carry out similar projects are to be furnished in the format provided in the **Appendix D** along with documentary proofs. Similar projects will include projects done in the Defence sector involving services, manufacturing, overhauling, repair, maintenance modifications/upgrades or supply chain in last seven years

#### **Response Evaluation Process**

- 11. A Bidder Selection Committee will examine the competence of respondents to handle proposed project. Indian Army also reserves the right to include any outside consultants/experts in the said committee.
- 12. The Bidder Selection Committee will evaluate the submitted responses. Therefore, respondents should submit necessary details that would help in the assessment. However, Indian Army in its sole and absolute discretion can apply whatever criteria deemed appropriate in determining the responsiveness of the RFI submitted by the respondents.

#### **RFI Response Requirements**

- 13. Interested bidders may furnish their RFI response by giving all the necessary information and supporting documents as per the response formats for each of the requested information, as proof of having the minimum requirements. The response to RFI must contain all documents, information, and details as required by this RFI. Noncompliance/ incorrect/ incomplete submission will result in rejection of the submitted response. No representation in this regard shall be permitted.
- 14. All submissions, including any accompanying documents, will become the property of Indian Army. Recipients shall be deemed to grant all rights to Indian Army to reproduce whole or any portion of their submission for the purpose of evaluation, to disclose the contents of the submission to other recipients who have registered a submission and to disclose and/or use the contents of the submission as the basis for any resulting RFI process, notwithstanding any copyright or other intellectual property right that may subsist in the submission or accompanying documents.
- 15. **Right to Terminate the Process**. The Indian Army, reserves the right to issue a corrigendum to RFI, withdraw the RFI or/and reject any request for tender document or not to proceed with subsequent stages without assigning any reason at any stage.
- 16. **RFI Response Submission**. The response to RFI must be submitted in a sealed cover along with an application duly signed and stamped on all pages by an authorized signatory. The same must reach the following address on or before **1000 Hrs on 01 June 2020** in the following manner: -
